Opening date for ALL entries is Friday, July 15, 2016 at 8 am. All entries received before this date will be returned. Entries for Curly-Coated Retrievers will be given priority until 6pm August 15th after which time entries for all breeds will be accepted in the order they were received. No confirmation of entries will be sent until after August 15th, 2016. Entries close Tuesday, Sept 27, 2016 at 6 PM after which time entries cannot be accepted, cancelled, altered, or substituted except as provided for in Chapter 11, Section 6 of the Rules Applying to Dog Shows. Envelopes/transactions containing entries for more than the ten (10) dog maximum and/or entries received prior to the opening date shall be treated as an invalid entry and shall be returned to the sender.

Get on TN-155 s/Briely Pkwy, Take I-40 E towards Lebanon Take exit 239a Watertown , stay in right hand land - 3/10 mile turn right at light at stop sign turn left onto 266 Cainesville Pike Rd. go 7 miles to Beach Log Road on Left go approximately 2.3 miles to Never Go Back Ranch (on Left log cabin on top of hill) pass cabin to continue up to barn at top of hill

From Franklin / 840

take exit for Speedway, go right to Murfreesboro Rd at stop sign make left go to 265 Chicken Road go right drive about 6 miles to Cainesville pike rt 265 make right about 1 mile up road make Left on Beech Log Road follow above

Prizes and Awards

Rosettes will be awarded to the 1st through 4th place teams in each jump height in each class. Dogs must qualify to receive placement ribbons. Qualifying ribbons will be awarded to all dogs receiving qualifying scores. Highest Scoring Curly-Coated Retriever in each class will be awarded a prize. A more detailed list of awards will be available at the show.

Waiting list

A waiting list of up to 50 runs will be maintained. Per Chapter 1, Section 16.1 of the Regulations for Agility Trials, a "waiting list close date" will be instituted. **The "waiting list close" will be 6 pm, Friday, October 7th.** Full refunds will be given to those exhibitors withdrawing ONLY for the runs that are able to be filled from the waiting list.

Course Familiarization and Warm-Ups

Handlers in all classes are permitted to walk the course, without a dog, prior to the start of the class. The walk-through period allows handlers to plan their strategy running the course and will be held prior to each class, following the judge's briefing.

Notice To Exhibitors

- The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee.
- No entry will be refunded if the trial cannot be opened or completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of public enemy, or any other cause beyond the control of the organizing committee.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dog and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the show site. In such case, no refund of any fees will be made.
- Exhibitors are responsible for complete, accurate, and legible information on their entry forms; illegible or incomplete entries cannot be entered into the show. All entries must be made on Official AKC Entry Forms or copies and **must include the Agreement and Rules**. No Entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance.
- Handlers may opt to run in a higher height division, but not in a division lower than their proper height division. Dogs entered in the Preferred classes may **not** run in a higher height division.
- **Bitches in season and injured dogs** are not permitted to compete in Agility Trials. Entry fees will be refunded less a \$5 processing fee per run entered **with a certificate from a veterinarian**.
- All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area. **Judges are not required to wait for dogs.** The owner or handler of each dog is solely responsible for having it ready at ringside when its class is to be judged.
- Exhibitors are responsible for cleaning up after their own dogs. **Please** help us keep this site clean future use.
- Returned checks do not constitute a valid entry fee. The Trial Secretary will add a \$30 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitor may result in their being put on a cash only basis.
- NO Concessions will be available on site. Please plan accordingly 30 minutes to nearest fast food restaurant.
- **The show site will be available to exhibitors for set up after 3:00pm on Tuesday. Exhibitors will NOT be allowed to set up in the building before this time. No exceptions.**

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. INSTRUCTIONS

Handlers may opt to enter in a higher height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial *or back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine PartnersSM program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner? _____
