Owner desires the Foster Provider to hold said dog for Owner until this dog can be placed into a permanent home. The Owner recognizes that the Foster Provider cannot hold said dog for Owner for an indefinite period of time. In consideration of the premises and the covenants herein contained, it is agreed between the Foster Provider and Owner as follows:

- 1. Owner hereby delivers to and deposits with the Foster Provider said dog.
- 2. Upon the Owner's request, the Foster Provider will return the dog to Owner, which will be accomplished as soon as is practical.
- 3. Due to the unknown duration of care, and the need of the Foster Provider to know when the foster arrangement will be concluded, Owner agrees that the Foster Provider will not be responsible for keeping the dog any longer than six (6) months from the date of this Agreement.
- 4. Owner may extend the six (6) month period stated above if Owner gives written notice to the Foster Provider at least thirty (30) days before the end of said six (6) month period that he wants to extend for up to an additional (6) months the duration of his foster care agreement. If Owner does so, then this Agreement will continue for the additional time which Owner requests in writing up to but no longer than an additional six (6) months.

- 5. Foster Provider agrees not to alter in any way the appearance of the dog being fostered without written permission of the Owner.
- Foster Provider agrees to provide adequate food, water, shelter, and humane treatment for said dog at all times. In addition, Foster Provider agrees to adhere to all state and local dog laws. Foster Provider agrees to follow all oral and/or written additional instructions from the Owner.
- 7. If said dog dies or becomes accidentally injured, ill, or lost, Owner does not hold the Foster Provider responsible and releases the Foster Provider from any claim arising from said injury.
- 8. If said dog bites or injures any human or other dog, Owner will hold harmless and indemnify, and protect the Foster Provider, from any claim or suit filed by anyone as a result of such an incident.
- 9. The Foster Provider may seek veterinary care on behalf of the Owner. The pet Owner acknowledges that should medical care and attention for the dog be warranted, the Owner authorizes up to \$ 250 to be provided to cover the cost for care. The Foster Provider will submit a Veterinary Services Form for any care received and to receive reimbursement. In addition, the Foster Provider reserves the right to euthanize the dog should a veterinarian deem the dog's health to be so impaired that to sustain the dog would be inhumane.

This Agreement is the entire agreement of the parties, and there are no oral promises or representations made in addition to this contract and it may only be changed in a writing signed by both the Foster Provider and Owner.
